Subject:- Upgradation of the school from Secondary to Senior Secondary level in Humanities and Commerce w.c.f. the academic year 1998-99.

Sir,

With reference to your application dated 11.2.98 on the subject cited above, I am directed to convey the approval of the Director of Education, Delhi, for the upgradation of the school from Secondary to Senior Secondary level without aid w.c.f. academic year 1998-99 subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provisions of the DSEA & R 1973 as well as the instructions issued from time to time by the Directorate of Education.
2. That the school shall admit students without any discrimination of caste and creed.
3. That the school shall meet the additional liability of Senior Secondary classes.
4. That the school library shall maintain books at the ratio of 10 books per student.
5. That adequate sports material shall be purchased and made available to the students.
6. That the school shall strictly abide by the provisions of Section 10(i) of DSEA & R 1973.
7. That the school shall not run any unrecognised classes or any other activities in the school premises and all recognised classes shall run at one place.
8. That the school shall dispense with the services of unqualified and overaged staff immediately.
9. That the Management Committee shall regulate the functioning of the school strictly in accordance with the provisions of DSEA & R 1973.
10. Managing Committee of the school shall not increase fee during academic session without prior approval of the Director of Education which is mandatory under sub section (3) of section 17 of the DSEA & R 1973.
11. That all the conditions of the rule 50 of DSEA & R 1973 shall be fulfilled and facilities under rule 51 of DSEA & R 1973 shall be made available to the students.

12. That proof to the effect that qualified staff has been appointed as per norms be provided for verification to the Education Officer concerned.
13. That the arrangements for good drinking water shall be made available to all the students as well as the teachers and sanitary arrangement as per norms be made in the school.
14. That the school shall comply with norms of the CBSE for affiliation for examination purpose.
15. Medical facilities, leave, LTC, Bonus, teaching allowances, CPF and other related facilities be provided to the staff as per Govt. norms.
16. Provident Fund Register will be maintained and Cash Book completed and shown to the E.O of the Zone concerned for verification from time to time.
17. That the violation of any rules and regulations of DSEA & R 1973 and instructions of the department shall lead to the withdrawal of recognition of the school.
18. That the report about fulfilment of above conditions shall be sent to the E.O. concerned within six months.
19. That the school shall file returns as specified under rule 130 of DSEA & R 1973 by the prescribed date.
20. That the school shall maintain high academic standards.
